

POWER OF ATTORNEY FOR THE GENERAL MEETING OF SHAREHOLDERS OF ACCELL GROUP N.V. TO BE HELD ON APRIL 28, 2011

The undersigned:

Shareholders may only use this power of attorney form if prior to the meeting they submit a statement of a bank or a broker in which administration they are registered as holders of the shares. The statement of the bank or the broker should mention the number of shares which the shareholder beneficially owns on the record date (March 31, 2011).

An application for such statement must be made to the bank or broker prior to April 19, 2011. The statement of the bank or broker is regarded to be an admission ticket for the meeting.

According to the articles of association no person is allowed to exercise voting rights on behalf of more than ten shareholders.
